

> NONSUBSCRIBER PREPRINTS/TOTAL MARKET COVERAGE

Nonsubscriber preprint delivery is delivered midweek* by ZIP code in King and South Snohomish counties. Delivery is via the U.S. Postal Service inside Savings Source, a full color, all-advertising wrap. When added to Sunday or weekday newspaper delivery, this program provides total market coverage. Minimum distribution is 10,000 pieces. Nonsubscriber distribution must run the week of, week before, or week after the newspaper delivery.

*Tuesday – Thursday delivery; billed as Wednesday.

Rates are based on weight and are subject to change based on postal rate changes. Billing weight is confirmed at time of insertion.
